

What is Mexico's energy goal?

According to Mexico's Energy Transition Law (Ley de Transición Energética) and General Climate Change Law (Ley General de Cambio Climático), Mexico's goal is 35 percent of electricity from clean energy sources by 2024, which includes power regeneration from renewable and non-renewable sources such as nuclear and efficient cogeneration.

How much solar power does Mexico need in 2024?

To meet the 35% clean energy target in 2024, Mexico needs at least 128.83 TWh or 42.56 TWh of additional clean energy generation. National solar PV capacity potential is estimated at 24,918 GW.¹ This potential capacity could generate 50,196 TWh/yr or 137 times the 365 TWh estimated demand for Mexico in 2024.

Which energy sources can be used in Mexico?

From all the clean energy sources in the country, two have enormous potential: Solar or photovoltaic energy for the center and north of Mexico. According to international studies, our country is located in the coordinates most favored by the sun's rays, which translates into an unparalleled natural opportunity to collect solar renewable energy.

Is green hydrogen a good opportunity for Mexico?

For instance, on March 15, the Mexican Hydrogen Association was invited to the Mexican Congress to lead an "Innovation and Technological Forum on Green Hydrogen, Challenges and Opportunities", where there was a recognition that green hydrogen is a great opportunity for Mexico to reach clean energy and decarbonization goals.

Can solar be used as a wind energy source in Mexico?

Solar deployment can follow wind transmission. Targeted grid upgrades, if any, for wind, will benefit solar as well because solar resources exist in all areas of the country. Solar potential in Mexico is six times larger than wind, and the technology complements wind generation very well.

How much wind power will Mexico generate in 2024?
