Are energy storage subsidy policies uncertain?

Subsidy policies for energy storage technologies are adjusted according to changes in market competition, technological progress, and other factors; thus, energy storage subsidy policies are uncertain. What are China's energy storage incentive policies?

China's energy storage incentive policies are imperfect, and there are problems such as insufficient local policy implementation and lack of long-term mechanisms. Since the frequency and magnitude of future policy adjustments are not specified, it is impossible for energy storage technology investors to make appropriate investment decisions.
