#### What is MN8 bifacial solar?

The contract is for 170 MW of Series 6 Plus bifacial modules and 287 MW of Series 7 modules which will be used in projects in the northeastern and southern US, according to a statement released today. Formerly known as Goldman Sachs Renewable Power LLC (GSRP), MN8 owns and operates 3.2 GW of solar capacity.
