

Will ExxonMobil bring oil & gas to Namibia?

ExxonMobil director of South Atlantic Exploration, Richard Barke, said oil and gas will be a critical part of the global energy mix for years. "We need to keep exploring," Barke said. According to Barke, his company wants to bring the model they used in Guyana to Namibia.
