## Netherlands photovoltaic energy storage policy

Are batteries a barrier to energy storage in the Netherlands?

Under the Electricity Act 1998, generation is exempt from the payment of transmission costs, but consumption is not. This highlights one of the main barriers to energy storage in the Netherlands, as batteries currently pay more transmission costs than polluting wholesale consumers.

Do Dutch grid operators have to compensate solar rooftop owners?

In May 2020, the Dutch government said that grid operators were not obliged to compensate the owners of solar rooftops whose arrays are disconnected due to problems with grid capacity and voltage quality.

Is the Netherlands still a gas producer?

The Netherlands is still one of the largest gas producers in Europe; however, domestic gas supply and gas exports are rapidly declining as production from Groningen is being phased out. Domestic oil supply is small, especially in comparison to the large oil demand.
