#### What happened in Escondido?

While no one has been injured by the fire -- which may take up to 48 hours to burn itself out -- evacuation orders remain in place in the largely industrial part of the city. Fires like the one in Escondido have caused some groups to become wary of the large battery storage facilities.

Will SDG&E put a pause on battery storage facilities in Escondido?

After last week's lithium battery fire at an SDG&E battery storage facility in Escondido, the Board of Supervisors will consider putting a pauseon future such facilities.

Could a moratorium freeze AES' Seguro storage project in Escondido?

Should the supervisors elect the moratorium route, it could freeze the proposed AES' Seguro storage project in Escondido, not far from where Thursday's fire took place. This project would be capable of storing up to 320 megawatts or 1,280 megawatt hours worth of energy -- several times larger than the facility where the fire continues to burn.

Did Escondido fire cause evacuation orders?

Update: Evacuation orders were liftedSaturday after the battery fire was out. "Over the coming weeks,the Escondido Fire Department and SDG&E will conduct a thorough investigation to determine the cause of the fire," officials from the city of Escondido said in a statement.

Where is the Escondido battery fire?

Are Bess fires on the radar?
