

New energy storage project grid connection policy

How can energy storage help the electric grid?

Is energy storage a viable resource for future power grids?

With declining technology costs and increasing renewable deployment, energy storage is poised to be a valuable resource on future power grids--but what is the total market potential for storage technologies, and what are the key drivers of cost-optimal deployment?

Is grid interconnection causing project delays & cancellations?

The Federal Energy Regulatory Commission (FERC) adopted major interconnection reforms in 2023 that have not yet taken effect in most regions; project developers continue to cite grid interconnection as a leading cause of project delays and cancellations.

What is the 'guidance on accelerating the development of new energy storage?

Since April 21,2021,the National Development and Reform Commission and the National Energy Administration have issued the 'Guidance on Accelerating the Development of New Energy Storage (Draft for Solicitation of Comments)' (referred to as the 'Guidance'),which has given rise to the energy storage industry and even the energy industry.

What could drive future grid-scale storage deployment?

By 2050,annual deployment ranges from 7 to 77 gigawatts. To understand what could drive future grid-scale storage deployment,NREL modeled the techno-economic potentialof storage when it is allowed to independently provide three grid services: capacity,energy time-shifting,and operating reserves.

Why is new electric generation and storage important?

U.S. electric demand is projected to increase considerably in coming years,with a resurgence in U.S. manufacturing alongside demand from new data centers,electric vehicles,and building electrification. Connecting new electric generation and storage is urgently needed to meet this growing demand.
