Vattenfall has signed an agreement with RWE to divest the Norfolk Offshore Wind Zone. The agreed purchase price corresponds to an enterprise value of £963 million. The deal ensures the continued development of the projects and fossil-free electricity for millions of British homes.

Will Vattenfall make a profit from the Norfolk zone deal?

The deal ensures continued development of the Norfolk Zone which will produce clean power for over four million homes across the UK. Vattenfall will record a capital gainfrom the transaction, the exact amount to be communicated in the forthcoming interim report for January-March 2024.

Why did Vattenfall sell its offshore wind zone to RWE?

In December 2023, Vattenfall agreed to sell its Norfolk, UK, offshore wind zone to RWE for an enterprise value of £963m (\$1.2bn). The transaction enables the continued development of three wind farms with a combined capacity of 4.2GW, sufficient to power four million British homes.

Who owns the Norfolk offshore wind zone?

Vattenfall has today completed the sale of the Norfolk Offshore Wind Zone to RWE. The agreed purchase price corresponds to an enterprise value of £963 million. The deal ensures continued development of the Norfolk Zone which will produce clean power for over four million homes across the UK.

What does Vattenfall want from RWE?

It is one of the largest offshore wind developments in the world, with a total capacity of 4.2 GW, equal to the electricity consumption of 4 million British households. Vattenfall believes the agreement with RWE is the best way forward both for the company and for the Norfolk projects.

Why did Vattenfall divest from RWE?

Vattenfall believes the agreement with RWE is the best way forward both for the company and for the Norfolk projects. With the divestment, Vattenfall increases its ability to invest in fossil-free projects that better fit its overall portfolio and risk appetite, while the future of the Norfolk Offshore Wind Zone is secured.

The BESS production is part of the commissioning process for the facility in Gdansk while the funding is an extension of the US\$1.1 billion convertible it signed in July 2022, covered by Energy-Storage.news at the time. A convertible note is a debt instrument that converts to equity at a later date instead of paying interest.

Vattenfall said that the Norfolk Boreas offshore wind farm will be developed alongside the Norfolk Vanguard project, which is waiting for its own consent decision, in the Norfolk Zone. The Norfolk Zone has 3.6GW of installed capacity and is part of the industry's goal to create 70,000 jobs by 2026.

Battery@Ray is a 20 MW / 45.5 MWh Battery Energy Storage System (BESS) co-located at Ray Wind Farm. The BESS will help keep the electricity grid stable and enable excess electricity to be stored and fed back into the grid.

The largest operational BESS facilities in Europe are both in the UK, both owned by developer-operator Harmony Energy totalling 99MW/198MWh each. The Alfeld project is Kyon"s second large-scale BESS project approval in the space of a few weeks, after a 58MW/116MWh system was given the green light by regulators at the end of October .

The Norfolk Vanguard wind farm will comprise 90 to 180 turbines with heights of up to 350m. Vattenfall has not yet confirmed which turbine supplier it will use. The wind farm will lie 47km offshore from Happisburgh, Norfolk, where the connection cable will make landfall. The cable will then continue for 60km onshore to a

substation.

Northvolt has launched a new battery energy storage solution, Voltpack Mobile System- a rugged, highly modular lithium-ion battery solution envisioned as a zero-emission alternative to replace diesel generators. Vattenfall has supported the design of the system and will test and validate Voltpack Mobile System and its functionality prior to the market introduction.

The BESS is comprised of two containerised BESS units with a precise storage capacity of 7,442kWh and the grid connection capacity is up to 7,560kWh. Although the announcement didn"t say it, pictures provided showed it was provided by system integrator Intilion (the company which recently pulled IPO plans), which is also based in Germany.
