

Will ESM & SOCAR strengthen energy stability in North Macedonia?

Nov 14 (Reuters) - North Macedonia's ESM power utility and Azerbaijan's state energy company SOCAR on Thursday signed a memorandum of understanding aiming to strengthen energy stability in the Balkan country, ESM said on its website.

Are wind power projects a good opportunity for North Macedonia?

What's wrong with North Macedonia?

A downside of the current situation in North Macedonia, in spite of its determination for intensified energy transition while harmonizing policies in accordance with the EU recommendations¹², is that the country is still struggling with air pollution, waste management issues, and poorly managed energy market liberalization.

What is the energy strategy for North Macedonia?

The Ministry of Economy of North Macedonia announced earlier in 2020 that "the (energy) strategy envisions investments in photovoltaic power plants which are expected to have a total installed capacity of 1.357 MW, or 41.8% of the total installed capacity for energy production."^{41 36} European Commission.

Is North Macedonia reliant on fossil fuels?

According to the national and international statistics, such as those run by the World Data and the International Energy Agency, North Macedonia remains reliant on fossil fuels²⁸. Majority of its total energy mix, both on supply and demand side, still falls under the category of fossil fuels (Figure 2), mostly due to the usage of coal and oil.
