## Overseas energy storage bid winning announcement

How many battery energy storage projects have won a bid?

Over a gigawatt of bids from battery storage project developers have been successful in the first-ever competitive auctions for low-carbon energy capacity held in Japan. A total 1.67GWof projects won contracts, including 32 battery energy storage system (BESS) totalling 1.1GW and three pumped hydro energy storage (PHES) projects totalling 577MW.

Which solar-plus-storage projects were bidding in Germany's latest innovation auction?

All the bidding projects from Germany's latest innovative auction were a combination of solar with energy storage. Image: Convergent Energy + Power. Germany's latest innovation auction has awarded contracts to 32 solar-plus-storage projects with a cumulative capacity of 408MW.

Will Hungarian energy storage projects get subsidy support?

The Hungarian Ministry of Energy has announced that around 50 grid-scale energy storage projects with a cumulative capacity of 440 MW have received subsidy support through a tender launched in February this year.

How many energy storage projects are there in India?

The country announced its 1 GW energy storage program in the summer with three separate tenders featuring 400 MW, 300 MW and 300 MW of capacity. The first tender awarded 12 energy storage projects in August, with 411,79 MW of capacity in total. The second auction aims to award another 288,21 MW of storage capacity.

How does Greece support energy storage projects?

Greece's subsidy support for winning energy storage projects in the upcoming tenders is generous. During the construction phase, all winning projects will receive a one-time payment of EUR200,000 per MW, which serves as a capital expenditure subsidy.

Can energy storage projects enter a power purchase agreement with private investors?

Energy storage projects participating in Greece's program are prohibited from engaging in the energy derivatives market and are unableto enter power purchase agreements (PPAs) with private investors. Tender rules
