# Overseas solar energy storage bidding documents

Which solar-plus-storage projects were bidding in Germany's latest innovation auction?

All the bidding projects from Germany's latest innovative auction were a combination of solar with energy storage. Image: Convergent Energy + Power. Germany's latest innovation auction has awarded contracts to 32 solar-plus-storage projects with a cumulative capacity of 408MW.

#### Where can I find solar tenders?

A good starting point is Solar Tenders Worldwide,a subscription service that lists live government tenders related to solar projects. In Europe, public sector tenders over a certain value (EUR428,000 for energy) must be published in the Official Journal of the European Union (OJEU).

### What is a solar PV & energy storage innovation tender?

Launched in 2020, the innovation tender seeks to combine several renewable resources, however as shown in the latest auction all bids submitted have been for the combination of solar PV with energy storage.

### How do I find and apply for solar projects worldwide?

### How many mw was awarded in a solar-plus-storage tender?

As usual, the solar tender was significantly oversubscribed, luring 98 proposals of 493 MW in total, against a target of 100 MW. The awarded capacity was 100.55 MW, coming from 18 projects. The bid price ranged between EUR 0.0355/kWh and EUR 0.0521/kWh. January 2020,609 MWawarded in 2nd solar-plus-storage tender.
