What is the current state of RER generation in Peru?

Despite the progress made in the first years after the publication of DL 1002, the development of new RER projects has decreased. Section 9 has presented a summary of the current state of the RER generation policy and the recommendations to conduct the energy transition in electricity generation in Peru.

How much energy does Peru use?

Is the RER A reliable source of power in Peru?

Peruvian regulations establish that, as it is an intermittent resource, in many cases these generators have a null degree of control over their generation capacity, so they should not receive a payment for power and therefore it is stated that the RER they are unreliable 10.

Should Peru raise its energy goal with RER?

In successive statements by the Ministers of Energy and Mines, it was constantly said that Peru should raise its goal of electricity generation with RER, from 5 to 15% by 2030. Let us remember that the goal of 5% was established in DL 1002 of 2008, where it was also said that new goals would be established for future years. But this did not happen.

What is Peru's energy policy?

Peru's national energy policy (Propuesta de Política Energética de Estado Perú 2010-2040) aims to diversify the country's energy mix and emphasize renewable energy and energy efficiency in order to meet the country's long-term needs.
