How do asset owners manage a fleet of PV systems?

The asset owner or asset manager should allocate sufficient internal resources and secure any required external resources to implement the O&M plan. Operating and maintaining a fleet of PV systems requires active resource management and data acquisition and analysisby the asset and operation manager(s).

How much data should a solar monitoring system store?

Best practice is for dataloggers to store 6 months of data and to back up data to cloud storage. A reliable method to "back-haul" the data is required. Most connect to the internet via DSL, but be aware that many site owners will not allow the solar monitoring system to use the site network.
