

Can a standard photovoltaic plant be produced in Mexico?

In this study, the supposed production of the standard photovoltaic plant was determined for various Mexican states using the design tool "Sunny Designer" developed by SMA. Thereafter the production of standard PV plant was compared with results obtained from the data analysis.
