Will Poland build a nuclear power plant in South Korea?

At the same time, the state-run Polish Energy Group (PGE) and the ZE PAK energy conglomerate signed a letter of intent with South Korea's state energy company KHNP on developing plans for the construction of a nuclear power plant at P?tnów in south-central Poland, officials said.

Is Poland planning a second large nuclear power plant?

Poland's Ministry of Climate and Environment has issued a decision-in-principle for the country's second large nuclear power plant. Two South Korean-supplied APR1400 reactors are planned in the Patnów-Konin region. A plant comprising two APR1400 reactors (Image: KHNP)

Will Poland build a nuclear power plant?

Poland plans to build four to six nuclear reactors by the mid-2040s. The planned facilities could meet between 25% and 36% of annual domestic energy demand. Nuclear power is a key part of Poland's plan to reduce the large share of coal and lignite in electricity generation. Its electricity grid is one of the most carbon-intensive in Europe.

Will Westinghouse build a nuclear power plant in Poland?

Last July, Westinghouse launched so-called front-end engineering and design work under a grant from the US Trade and Development Agency to go ahead with the nuclear energy program in Poland. Price is also key. Korea's KHNP offered to build six 8.4 GW reactors for \$26.7 billion (EUR26 billion).
