

How do energy storage projects work in Poland?

The operational stage of a storage project also typically involves a process of support agreements such as O&M contracts, technical consulting, and power distributor agreements. Projects concerning energy storage, as with other infrastructure projects in Poland, require the necessary administrative permits to be obtained.

Are investments affecting Poland's power grid?

As in many other EU jurisdictions, in Poland the exponentially growing number of RES investments is causing disruption to the power grid. One solution to this problem is the large-scale development of energy storage facilities.

How does a capacity market unit work in Poland?

The functioning of a unit in the capacity market in Poland can be generally divided into three main stages--certification of the supplier and its capacity market unit, subsequent (main and supplementary) auction rounds and performance of the capacity obligation. BESS were awarded for the first time in a 2022 auction.

Will Poland rethink its capacity market if its coal fleet is decommissioned?

Poland, which has awarded expensive capacity payments to its aging coal fleet since 2021, will soon change its approach to the capacity market once its coal fleet is decommissioned from 2026 onwards. Accordingly, operational efficiency and ancillary services will play a greater role in ensuring a stable supply of electricity to consumers.
