Policy energy storage demonstration project

What is the energy storage demonstration and pilot grant program?

The Energy Storage Demonstration and Pilot Grant Program is designed to enter into agreements to carry out 3 energy storage system demonstration projects. Technology Developers, Industry, State and Local Governments, Tribal Organizations, Community Based Organizations, National Laboratories, Universities, and Utilities.

What are the different types of energy storage policy?

Approximately 16 states have adopted some form of energy storage policy, which broadly fall into the following categories: procurement targets, regulatory adaption, demonstration programs, financial incentives, and consumer protections. Below we give an overview of each of these energy storage policy categories.

How does energy storage work?

During the process of charge and discharge, energy storage switches identity from that of a user to that of a power generator. Peak-shaving compensation and feed-in charges cannot be paid repeatedly, while independent energy storage projects are also faced with the risk of double charges.

Should energy storage charge and discharge strategies be adjusted?

Shandong, Gansu and other regions implemented complete price adjustments for all TOU periods. While the widening of the peak and off-peak price difference is beneficial to behind-the-meter energy storage applications, energy storage charge and discharge strategies must also be adjusted to the changes to the peak and off-peak period.

Which universities have added energy storage disciplines?

Xi'an Jiaotong University, North China Electric Power University, and other colleges and universities have already added such energy storage disciplines.

What is energy storage & why is it important?
