

How does energy storage affect investment in power generation?

Energy storage can affect investment in power generation by reducing the need for peaker plants and transmission and distribution upgrades, thereby lowering the overall cost of electricity generation and delivery.

Do charge power and energy storage capacity investments have O&M costs?

We provide a conversion table in Supplementary Table 5, which can be used to compare a resource with a different asset life or a different cost of capital assumption with the findings reported in this paper.
