## **SOLAR PRO.** Power storage tax incentives

Which energy storage technologies qualify for the clean electricity investment credit?

The technologies recognized in today's NPRM include wind, solar, hydropower, marine and hydrokinetic, nuclear fission and fusion, geothermal, and certain types of waste energy recovery property (WERP). The proposed guidance also clarifies how energy storage technologies would qualify for the Clean Electricity Investment Credit.

What are the clean electricity tax credits?

"The Clean Electricity Tax Credits created under the Inflation Reduction Act provide certainty to the market and are poised to drive substantial further growth and lower utility bills over the long-run."

What tax credits are available for energy projects in low-income communities?

In addition to the bonus for the Investment Tax Creditfor projects in low-income communities, the Inflation Reduction Act: Provides a bonus credit of up to 10 percentage points for qualifying clean energy investments in energy communities.

Are the clean electricity production & investment credits a good idea?

Outside studies have shown that the Clean Electricity Production and Investment Credits are key to accelerating U.S. emissions reductions and achieving President Biden's climate and clean energy goals.

What is IRS Energy Credits online (eco)?

Final rules on elective pay were issued in March. To facilitate taxpayers transferring a clean energy credit or receiving a direct payment of an energy credit or CHIPS credit, the IRS built IRS Energy Credits Online (ECO) for taxpayers to complete the pre-file registration process and receive a registration number.

Can I claim the clean electricity production credit?

The Clean Electricity Production Credit is eligible for direct payment or transfer. Taxpayers cannot claim both investment credit and production credit for the same facility. Qualified facility owners (or operators under certain circumstances) can claim an annual credit for a specified period based on one of the following:
