

Where is powertis based?

Powertis,a Soltec Power Holdings company,has begun construction of its first photovoltaic plants in Brazil,located in Pedran&#243;polis (S&#227;o Paulo) and Arax&#225; (Minas Gerais),with a total capacity of 225 MW (112.5 MWp each).

What is powertis project?

The project,led by Powertis,a company dedicated to the development of solar photovoltaic projectsin Brazil,Italy and Spain,will meet the annual electricity supply of 230,000 homes between the two plants and will prevent the emission into the atmosphere of approximately 350,000 tonnes of CO2 per year.

Where are powertis Pedran&#243;polis & Arax&#225; plants located?

The Pedran&#243;polis and Arax&#225; plants,located in the states of S&#227;o Pauloand Minas Gerais respectively,will feature trackers from Powertis's parent company,Soltec,which will also provide assembly and construction services.

How many GW does powertis have?

Powertis has a project portfolio of more than 2 GWin various stages of development in the Brazilian market. In addition,the company has 2 GW in Spain and more than 1 GW under development in Italy. Over the next few years,the company expects to continue increasing its presence in these countries,as well as analysing entry into new markets.
