Historically, the costs of operating the Moroccan electricity system have exceeded the revenues collected from ratepayers. Typically, ONEE has waited several years between tariff adjustments at which point tariffs are raised to a point nearing cost-revenue balance.

Do Moroccan electricity consumers still pay the same for electricity?

Electricity tariffs: This scenario assumes Moroccan electricity consumers continue to pay the samefor electricity as they did in 2013 in all years between 2014 and 2030. In addition, this assumes that cost-based tariffs are not implemented at any point and that revenue recycling does not occur at any time.

Does Morocco need a primary energy supply?

The primary energy supply has increased significantly in the past. Morocco is highly dependent on imports of energy sources; in 2015,the dependency was about 94.5%. Morocco experienced a significant increase in demand for primary energy it has increased by 0.36 TOE per capita in 2002 to 0.56 TOE in 2015.
