# **SOLAR** PRO. Recycling photovoltaic Equatorial Guinea

#### What are the recycling procedures for solar panels?

Klugmann-Radziemska (2011) discussed the reuse of the solar panels and the impact on the economy in PV recycling industry. However, the recycling procedures are different based on PV module types such as c-Si, Thin film and CdTe. The recycling procedures such as mechanical, thermal, chemical treatment involved in any PV recycling.

#### Is PV module recycling mandatory in Europe?

As described in Chapter 2,PV module recycling is mandatoryin Europe,whereas in other countries, actions promoting PV module recycling are under development; hence, information on current PV EOL treatment methods available in the market will be useful to understand the current situation and to encourage projects for PV module recycling.

#### How are PV modules recycled?

Out of the 5 recycling companies, 4 of them used mechanical processes to separate the various components of the PV modules, while one used a combination of mechanical, thermal, and chemical methods. The recycling processes of the first four recyclers are similar. Company #1 follows the process in a laminated-glass recycling company.

#### Where is PV module recycling & EOL management available?

In Asia and the Pacific, there are currently no nationwide schemes for PV module recycling and EOL management; however, some countries are implementing various discussions and activities for promoting the proper EOL management of PV module waste. This section presents the status of PV module recycling in Japan, South Korea, China, and Australia.

### Who recycles CdTe PV modules?

First Solar, which is the world's largest PV recycler [83,84], has a recycling capacity of 150 metric tons/day in the US for its thin-film CdTe PV modules . Using a high-value recycling process, First Solar recovers 90% of both bulk (e.g., glass) and specialty materials (e.g., CdTe semiconductor layer) from EOL CdTe PV modules .

Is e-waste recycling a viable option for solar PV?

As per the E-waste management and handling Rules,2011,there is no provision on the solar PV waste (Sykorova et al.,2018). Even the conventional recycling facilities for glass (laminated) and e-waste are unavailable. The process of recycling the solar module is not attractive commercially (Komoto et al.,2018; Kiddee et al.,2013).
