But batteries are costly and store only enough energy to back up the grid for a few hours at most. Another option is to store the energy by converting it into hydrogen fuel. Devices called electrolyzers do this by using electricity--ideally from solar and wind power--to split water into oxygen and hydrogen gas, a carbon-free fuel.

Salt River Project announced it has signed a contract with a subsidiary of NextEra Energy Resources to add a 100-megawatt (MW) battery storage system to the existing 100-MW solar plant, Saint Solar, located in Coolidge, Ariz., which is currently serving SRP customers. The 100-MW battery, expected to be operational in June 2023, will provide four...

The PPA will lead to the construction of a minigrid that comprises a 568-kWp/500-kW solar farm, a 2.7-MW wind farm and a 3.2-MWh/3.5-MW battery storage facility. According to PASH Global, this hybrid project will deliver the lowest cost power on the island.
