### Who is the owner of the Saudi power projects?

The Saudi Power Procurement Company (SPPC)ownsthe five recently launched renewable energy projects. The projects include producing power through solar and wind, and the SPPC is the principal buyer. No financial details were disclosed.

#### Is Saudi Arabia a solar power hub?

Saudi Arabia's vast and arid regions are considered a great hub for solar potential. Rich in sunlight and gas, the Kingdom is moving toward diversifying its domestic power supply, and companies such as Saudi Aramco have been using PV panels as a renewable energy source since the 1980s.

#### How much power does Saudi Arabia need?

Saudi Arabia has established a goal to source at least 50 percent of its power from renewable energy by 2030,expanding its capacity to 130 gigawatts(GW),58.7 GW of which is expected to come from solar and 40 GW from wind. This target is the most ambitious of its kind among Gulf Cooperation Council (GCC) countries (Figure 1).

What is a Saudi wind power agreement?

The first agreement involves a JV with the wind power technology company Envision Energy and the Saudi firm Vision Industries. It will involve manufacture and assembly of wind turbine components including blades with an estimated annual generation capacity of 4 gigawatts (GW).

Who owns the Saudi Water Partnership company?

The Ministry of Financeowns fully (100%) the Saudi Water Partnership Company.

Why is Saudi Arabia partnering with China?

These partnerships provide Saudi Arabia with advanced technology and financing options while allowing China to secure vital energy resources, strengthen its Belt and Road Initiative, and gain greater access to Middle Eastern energy markets.
