Who is Singapore Power Group?

What is the separation of powers in Singapore?

The Separation of powers in Singapore is governed by Constitution of the Republic of Singapore, which splits the power to govern the country between three branches of government - the parliament, which makes laws; the executive, which executes them; and the judiciary, which enforces them.

Why does Singapore have a judiciary?

The judiciary also defers to the executive where non-justiciable matters are involved. Judicial independence in Singapore allows the judiciary powers to check the exercise of power by the other branches of government, strengthening the separation of powers.

How can Singapore diversify its energy supply?

For example, Singapore must diversify its energy supply by having more electricity imports and using low-carbon hydrogen for power generation, as part of nine recommended strategies laid out in the 56-page report.

Will solar power decarbonise Singapore?

Solar energy is one of EMA's " four switches " vital to decarbonising Singapore- the others being natural gas, regional power grids and low-carbon alternatives. Singapore plans to import up to 4GW of low-carbon electricity by 2035, which could make up around 30 per cent of Singapore's projected electricity supply then.
