How is energy used in Slovak Republic?

Total energy supply (TES) includes all the energy produced in or imported to a country, minus that which is exported or stored. It represents all the energy required to supply end users in the country.

Is Slovakia a net exporter of electricity?

From 2024, following the completion of two new nuclear reactors, Slovakia will return to being a net exporter of electricity. Slovnaft is the largest oil refinery in Slovakia.
