Does Ecuador have a net metering scheme?

As explained before, Ecuador has implemented a net-metering schemewith 2 years of rolling credit. The customer will be able to discount the amount of energy that is delivered to the grid and reduce their monthly consumption, which will allow them to access a lower cost of electricity, as shown in Table 4.

How does electricity billing work in Ecuador?

In Ecuador, the price of electricity is set by the board of the ARCERNNR (formerly ARCONEL) and is valid for one calendar year. The final value of the electricity billing is established through the addition of several elements, namely the amount of energy, electrical output, losses in transformers, marketing, and penalties for low power factor.

Is there a potential for electricity generation in Ecuador?

Based on what has been described, it is identified that there is a high potential for electricity generation in Ecuador, especially the types of projects and specific places to start them up by the central state and radicalize the energy transition.
