Is offshore solar the only place to go?

Sometimes offshore is the only place to go. Without available space for such a project, densely populated Singapore is nearing completion of a 5 MW peak offshore floating solar farm in the Straits of Johor, between Singapore and Malaysia.

Why did a leading energy company decline a move into offshore solar?

A leading energy company recently declined a move into offshore solar because of the saltwater consideration, which massively affects the durability of the system. PV modules, the key component in solar systems, are not designed for salty environments. Even when PV modules are located on shore but near to the sea, corrosiveness can be a problem.
