

What is Infinity Power Holding?

Infinity Power Holding B.V is a joint venture between Egypt's Infinity and Masdar (Abu Dhabi Future Energy Company) to target power generation projects through renewable energy sources, namely solar and wind technologies on the utility-scale, as well as commercial and industrial scale in Africa.

Who owns Infinity Power?

The transaction makes Infinity Power the largest renewable energy company on the African continent. Infinity's key stakeholders include Africa Finance Corporation (AFC) and European Bank for Reconstruction and Development (EBRD).

How big is infinity power?
