Ride the St. Kitts Scenic Railway Source: flickr St. Kitts Scenic Railway Encircling the entire island of St. Kitts, from Conaree Village in the south to Dieppe Bay Town on the north coast and Brimstone Hill on the west side, this winding railway was once the principle means of transporting sugarcane down from the plantations to the docks for trade.

The islands of St. Kitts (168 km <sup>2</sup>) and Nevis (93 km <sup>2</sup>) are located in the Lesser Antilles chain of islands in the eastern Caribbean. They are separated by a channel of just over three kilometres. The islands were inhabited first by the Sibonay who arrived approximately 2000 years ago from Central America.
