

What are the main sources of energy in Gabon?

(October 2009) Energy in Gabon comes from two main sources, fossil-fuels and hydroelectricity. Gabon also relies heavily on oil for its export revenues, exporting both crude oil and petroleum. In terms of its oil reserves, the country is one of the richest in sub-Saharan Africa, ranking 5th after Nigeria, Angola, Sudan, South Sudan, and Uganda.

Who controls the oil industry in Gabon?

The government of Gabon controls all petroleum and mineral rights within the state. In 2011 a presidential decree created the Gabon Oil Company (GOC). This new entity works in partnership with international companies operating in Gabon and operates two fields: Obangue and Remboué.

Gabon, a former OPEC member (1975-1994) that rejoined in 2016, is the sixth-largest oil producer in sub-Saharan Africa. The first national oil company was the Société Nationale Pétrolière Gabonaise but it was disbanded in 1987. The government of Gabon controls all petroleum and mineral rights within the state.

How much electricity does Gabon produce?

Gabon's total electricity production in 2015 was 199 kilotonnes of oil equivalent (ktoe), with 51.7% produced from hydropower sources and 48.2% from fossil fuels. The country's final consumption of electricity was 169 ktoe.
