Our half day is 4 hours and the rate is \$525 plus fuel. Fuel charges differ depending on where you go. To visit some places around St. John, a few of the British Virgin Islands (any combination of Tortola, Norman Island, Jost van Dyke, etc.) it would be around \$160; anywhere between \$150-175 depending on where you go and how much you bounce around.

The British Virgin Islands (BVI), a group of islands in the Caribbean, is geographically dispersed, consisting of around 60 islands and cays, with roughly 30,000 residents spread across 15 inhabited islands.
