Premier Energy Group is a vertically integrated energy and power infrastructure company in the SEE region. With over 1000 MW of renewable electricity generation under ownership, management, or in development in Romania and Moldova, we are actively contributing to the renewable energy sector's expansion.

Who owns solar power in Romania?

The company, owned by Czech investment holding Emma Capital, has 1,000 MW of green projects under ownership, management or in development in Romania, evenly split between wind and solar and across the country. It built 10 MW of solar power in Moldova last year and is looking to add another 20 MW in 2024.

How much money does premier energy make in Romania?

Premier Energy began operating in Romania over a decade ago and its revenue has grown from 13 million euros (\$14.09 million) to roughly 900 million euros in 2023, including through 25 acquisitions.
