Does Sweden pay VAT on transport fuels?

On top of this,Sweden extended the coverage of its value-added tax (VAT) to include transport fuels in 1990. The VAT rate of 25 percent is applied to all components of the consumer price of gasoline: the production cost,producer margin,and excise taxes (energy and carbon taxes).

Are all Swedish service stations rebranded?

Circle K, which was Statoil until May 2016. All in all 490 Swedish service stations have been rebranded since then. Some chains have two prices, specifically for "bemannade stationer" (they cost more) and for "automatstationer" (they cost less).

Does Sweden have a gas tax cut?

Since 1960, there have only been three instances of nominal tax rate reductions gasoline in Sweden, each by marginal amounts in the range of 0.04 to 0.22 SEK per liter. Prior to the tax cut, the combined rate of the energy and carbon tax was 6.82 SEK per liter of gasoline.
