### Did Sterlite power raise Rs 725 crore?

NEW DELHI: Sterlite Power on Monday said it has raised Rs 725 crorein a primary fundraising round from GEF Capital Partners and ENAM Holdings. As part of Sterlite Power's demerger exercise, the Global Products and Solutions (GPS) business was hived out as an independent company in October 2024, a company statement said.
