Should project developers buy energy storage systems?

It's no secret that many project developers purchase energy storage systems only to meet the mandatory integration policy. These developers are hungry for low-cost storage products on the market with little care about the quality and performance, as they know those systems may never be used.

How a domestic energy storage system compared to last year?

In the first half of the year, the capacity of domestic energy storage system which completed procurement process was nearly 34GWh, and the average bid price decreased by 14% compared with last year. In the first half of 2023, a total of 466 procurement information released by 276 enterprises were followed.

Is China's energy storage industry in a crisis?

Despite this rapid growth, China's energy storage industry is still in its infancy, and crises has arrived much earlier than expected. A persisting price war and overcapacity weigh on profits Back in 2021 and 2022, battery supply was the biggest bottleneck for the energy storage supply chain.

What is the 'guidance' for the energy storage industry?

Based on the above analysis, as the first comprehensive policy document for the energy storage industry during the '14th Five-Year Plan' period, the 'Guidance' provided reassurance for the development of the industry.

What is the cumulative installed capacity of energy storage projects?

The cumulative installed capacity of new energy storage projects is 21.1GW/44.6GWh, and the power and energy scale have increased by more than 225% year-on-year. Figure 1: Cumulative installed capacity (MW%) of electric energy storage projects commissioned in China (as of the end of June 2023)

What is the leasing model for energy storage projects?

Another such model is the leasing model for front-of-the-meterenergy storage projects adopted by Hunan province in 2018, and the subsequent 2020 upgraded version of the leasing model which applied to energy storage paired with renewable generation and designed to split investment risks between each entity.
