Is Ti 2 ct x a good hydrogen storage material?

Compared with the known room-temperature hydrogen storage materials, Ti 2 CT x shows the superiority of low-pressure hydrogen storage, which is almost double of the previously reported highest storage capacity under the same pressure. Even under completely ambient conditions (25 °C and 1 bar air), Ti 2 CT x can still retain 4 wt% hydrogen.
