

Will York energy storage be able to build a power turbine?

Taking a first key step, York Energy Storage LLC applied Feb. 6 to the Federal Energy Regulatory Commission for approval to conduct a four-year feasibility study of a \$2.1 billion dam and power turbine project.

What is the York energy storage plan?

The York Energy Storage plan offers "pumped storage," where surplus power from peak production periods is used to pump water into reservoirs that can run turbines when needed. The proposal calls for a reservoir to be built on properties totaling 1,000 acres in Chanceford, York County.

What is a model C thermal energy storage tank?
