It also projects that the demand will be largely driven by mining and agricultural consumers and not residential consumers as projected in the COSS (Government of Zambia,2022). 4. Why should investors invest in Zambia's energy sector?

In the energy sector, only 31% of Zambia's 19.47 million people have access to electricity and the majority of these are in urban areas. This creates an enormous opportunity for investors to address the glaring deficits. 85% of Zambia's 2,800MW installed electricity generation capacity is derived from hydropower.

Will the demand for power continue to rise in Zambia?

While the Zambian government accepts that the demand for power will continue to rise Zambia, it has taken the view that the demand will be much higher than the 95% projected under the COSS.
