How can Zambia close the energy access gap?

Zambia will need to adopt a comprehensive and robust approach to address these challenges to close its energy access gap and reach universal access to clean, modern, reliable, and affordable energy. The electricity supply industry in Zambia has been dominated by the development of state-owned utility-scale power generation infrastructure by ZESCO. Private sector participation in Zambia's electricity supply industry has been few and far between, only emerging in 2001.

What is Zambia's Electricity generation & demand profile?

In 2021, the installed capacity had increased significantly owing to the construction and commissioning of two (02) machines at Kafue Gorge Lower power project. The national installed electricity capacity increased to 3,318.4 from 3,011.2 MW in 2020 as detailed below.
